The brevity of that response should not cause us to under-value its essential meaning: democratic republics are not merely founded upon the consent of the people, they are also absolutely dependent upon the active and informed involvement of the people for their continued good health.

We thank the many people and organizations in Rhode Island that represent American citizens and our form of government in a fight that should never happen—Americans against Americans, inside our country. The United States of America gives us a voice in our government, and we are a free people with individual rights, freedoms, and privileges. This is exactly what the people in other nations yearn for and why America has always been a leader and an example for the rest of the world. So, what has changed?

The lust for power—absolute power—is coming on strong. [T]he legislature is the end around the process.” He was responding to a survey done by the Providence Journal of General Assembly members on the issue of in-state tuition. The governor is also “still considering creating a state-issued driving license or permit for illegal immigrants . . .” **A little bit here, a little bit there, until they have it all.** This “policy” is just the beginning of more and more benefits for illegal aliens at the expense of American citizens—through our tax dollars, our economy, our jobs, our culture, and our way of life. The citizens of Rhode Island can be absolutely sure the issues of in-state tuition and drivers’ permits for illegal aliens will be addressed in the General Assembly in January 2012 with new legislation to prohibit these activities.

Illegal aliens will have a harder time securing a job as more Bay Area employers screen new hires through an immigration records check. More than 26,000 employers in the state have signed up for the federal E-Verify program that checks the immigration status of employees—including corporate giants Apple (APL) and Chevron, organic-friendly grocer Berkeley Bowl, and the non-profit Kaiser Permanente health care organization. Even though using E-Verify is voluntary, the number of California job sites using it increased by 37% to more than 90,000 from a year ago, according to government records. California now

has more job sites using the electronic verification system than any other state. Proponents say enacting E-Verify everywhere could deter illegal immigration more effectively than any border wall by denying all jobs to illegal immigrants. Republican presidential candidate Mitt Romney has made mandatory E-Verify a key talking point, and the House Judiciary Committee has already approved the Legal Workforce Act that would make E-Verify mandatory and replace I-9 forms. How E-Verify Works, Who uses E-Verify, and a listing of States with the Most Job Sites Using E-Verify are answered at the web site for this article (above).

For a list of every California employer with at least five employees signed up for E-Verify, go to www.insidebayarea.com or www.contracostatimes.com. Not included on the list are out-of-state E-Verify users, such as Walmart, that employ workers in California. As of Oct. 22, there were 297,433 employers nationwide using E-Verify, representing 968,981 job sites. Of those, 26,125 employers and 90,318 job sites are in California. According to a government database, a partial listing of Bay Area employers that use E-Verify include: The Gap, Ross Dress for Less, Williams-Sonoma, Cost Plus, UC Berkeley, Stanford University, Oakland Unified School District, Morgan Hill Unified School District, Facebook, Apple, Oracle, Intel, Hewlett-Packard, Chipotle Mexican Grill, Black Angus Steakhouse, Baskin-Robbins, Sizzler USA.

The Sonoma County Sheriff's Department and Santa Rosa police are joining other law enforcement agencies in the county and the state in accepting the bogus Mexican ID card--the Matricula Consular card. This is part of what ICE reported on these cards in their TRIPWIRE newsletter in 2003: The Matricula Consular is an identification card issued to citizens of Mexico residing in other countries, whether or not they are legally in that country, to include the United States. In practice, ICE has found that this card is most often carried by individuals who do not have lawful status in the U.S. Further, the U.S. Department of Justice has concluded that the matricula is not a reliable form of identification. No major bank in Mexico lists the card among identification it accepts, and only 10 of Mexico's 32 states and districts recognize the card as a valid identification document. The inherent danger in the use of such cards is that in matters of national security, identification verification and other crucial issues, the U.S. Government will be reliant on the scrutiny and security of foreign governments. **A little bit here, a little bit there, until they have it all.**

In 1996 California voters passed Proposition 209 to prohibit racial and ethnic preferences for admission to California's public colleges and universities. Proposition 209 amended California's state Constitution to read: *The state shall not discriminate against, or grant preferential treatment to, any individual or group on the basis of race, sex, color, ethnicity, or national origin in the operation of public employment, public education, or public contracting.* California Bill SB 185 would have restored those racial and ethnic preferences, but, surprisingly, Governor Jerry Brown vetoed that bill. "I wholeheartedly agree with the goal of this legislation." But he finds himself unable to sign it because, "Our constitutional system of separation of powers requires that the courts—not the Legislature—determine the limits of Proposition 209." The National Association of Scholars played a key role in promoting the original Proposition 209 and has worked with Ward Connerly, who heads the American Civil Rights Institute (see site below), to replicate the success of Proposition 209 in other states, including Washington, Michigan, Nebraska, and Arizona.
