Welcome to 2012 and the fundamentally changed government of the United States of America. Hoping, wishing, and ignoring do not change the truth. If you have been avoiding the truth, you won't like this.

The R.I. General Assembly is back in session, and you should know about the **three** political factions: Democrats (liberal), Republicans (conservative), and Progressive Liberals (ultra liberals who have taken over the Democrat party). Progressive Liberalism is the political agenda of the president and is now the controlling political faction across the country.

As a candidate, the president declared he would fundamentally change America, and he has. What he didn't specify was that the "change" would be our form of government, from a Representative Republic—government by and for the American people—into a "pure" democracy of **direct action** by the people--which is what you see happening in foreign countries where "the people" rise up against the government. OCCUPY is that direct action "democracy" the president wants. That is not what America is about.

The fundamental change is made through crises manufactured by the government to overwhelm, confuse, and deceive the American people. Whatever is going on publicly is not what is really happening. The Administration pushes their message of corporate greed so that Americans don't realize it is all about the **greed for power**. This is no longer about any individual country. That **greed for power** is about a **world government**, and the end justifies the means. The "end" they want is **world governance**, and the "means" are anything and everything the Progressive Liberal faction deems necessary to achieve that end. There is no right or wrong, no law and order, and no moral or ethical responsibility.

Countries wanting **world government** don't give a damn about their people. America does, and it stands in the way of the agenda for a **world government**. So, America has to be destroyed. They know a direct attack would fail, so they have been working for many years on the slow and steady infiltration and undermining of everything American—our Constitution, our culture, our beliefs and principles, our religions, and the American promise of **equal opportunity for individuals, not guaranteed success for selected groups of people**.

Currently, Progressives seem to be in charge; but in this agenda, the people who are really running things are not revealed until they have enough power to repel any resistance. They will partner with any group that can help them along; but when that group has served its purpose, it is cast aside for the next, more aggressive group. Once Americans have become accustomed to the "new normal," the next move is made, and on it goes until the end is reached and the real power behind the scenes is revealed.

Look at the other countries of the **world**. They don't believe in civil rights or human rights. They don't believe in freedoms for the people or government by the people. They do not allow any deviation from the absolute law of the government and give no moral or ethical consideration to the punishment for disobedience. "Civil disobedience" in those countries may have started with the people, but it ended with governments run by radical extremists—the **real** people behind the scenes. **World government** will rule with the brutality of those countries.

As a country united by its citizens, America cannot fail; so, the method is to divide Americans against each other. The American people are following like sheep, identifying themselves as part of “groups” based on their differences, believing the lies that, as a group, they will have **power**. They are doing the government’s dirty work by labeling themselves, making it easier for that **world government** to know who does not fit into the big plan. Only in America do you have the right and freedom to be “different.”

Rhode Island is following this agenda, straight from Washington, with those who have sold their souls for the promised **power** and those who will do anything, without conscience, to get that **power**. And the changes in “partnerships” have already started. By the end of the last legislative session, “minorities” were fighting each other for **political power**. Latinos make no secret that they want the **political power**, and the African-Americans who partnered with them as “minorities” are being deserted. The redistricting debacle is widening that divide and turning members of the same party against each other (e.g., Langevin saying that new lines benefit Cicilline), and changing the districts for new candidates. Is there gerrymandering? Of course there is! This is Rhode Island, and, like Washington, the end justifies the means.

The federal government does not have many duties specifically assigned by our Constitution, but one of them is clearly most important—to protect and defend our country and its citizens. That is not happening. Americans are abiding by our Constitution and what it stands for, but there comes a time for righteous indignation when we realize that our rights and freedoms are being perverted and used to destroy our country. The president is **ruling** by executive order and commissions, completely disregarding Congress. Governor Chafee is using commissions and executive orders to bypass the General Assembly. The city of Providence negotiates with OCCUPY that has its own General Assembly. OCCUPY is nothing new—it is a repeat performance of the tactics of ACORN and the SEIU “occupying” banks that refused to give mortgages to people who couldn’t afford them. Americans who support our country are on our own.

The president is stacking the National Labor Relations Board to strengthen the unions’ hold on businesses and stacking the courts with liberal justices who will rule according to social justice, economic justice, environmental justice, etc., instead of ruling according to our Constitution.

Will this be the year of the Czars—individuals **appointed** by the president and answer only to the president? They have been quietly working against America, but a lot of pieces have already been put into place so that they can now start to reveal what is really going on. The EPA will regulate businesses and American citizens into submission. The Consumer Finance Protection Bureau (part of Dodd-Frank Bill) will be telling the banks what to do, which could mean government control of who is allowed a business loan, a credit card, a student loan, a mortgage, or special consideration. This Bill could also repeat the mortgage debacle through extreme regulations and mortgage re-finance/forgiveness.

The president has decimated our military defense system with drastic cuts and much more to come. Military preparedness cannot be regained in time to protect our country. Will this be the year of the president’s civilian national security force? July 17, 2008, Candidate Obama: “We cannot continue to rely on our military in order to achieve the national security objectives we’ve set. We’ve got to have a civilian national security force that’s just as powerful, just as strong, just as well-funded.” “. . . **to achieve the national security objectives we’ve set**”? Knowing how the president “**uses**” words, exactly what are those security objectives, exactly how will they be enforced, and against whom? See insert.

Which brings us to the Second Amendment, the right to bear arms. The government is not directly saying that you cannot have “arms,” but its regulatory agencies will make it much more difficult for companies to manufacture guns and ammunition and for American citizens to “qualify” for a gun permit. The Department of Justice’s (DOJ) Wide Receiver and Fast and Furious Programs—that allowed drug cartels to buy guns in the U.S. and take them back across the southern border—were meant to increase the demand for stricter gun laws by creating the idea that criminals and terrorists were getting their guns from the U.S. The DOJ is still defending those programs in Congressional hearings and trying to avoid any responsibility—even though a U.S. Border Patrol agent was killed with one of those weapons that the **DOJ allowed to “walk.”**

The DOJ chooses which laws it will enforce. Whistleblowers testified that the Civil Rights Division refused to prosecute any cases where the plaintiff was white and the defendant black. They did not pursue intimidation at polling places even though victims were both black and white. This “justice” department attacks sovereign American states with federal lawsuits for enforcing U.S. immigration laws but does nothing about people who break our immigration laws and the officials and agencies that aid and abet the lawbreakers and create illegal sanctuary cities for them.

The Dream Act is a sham—a diversion. While this Act is out in the open, the president's back-door amnesty for illegal aliens is being put into place—selling visas for investing in American businesses, increasing work visas for jobs that only foreign workers can get, refusing to enforce our immigration laws and punishing our law enforcement personnel who try to enforce those laws, instructing Immigration and Customs Enforcement not to deport illegal aliens or even detain them. ICE has set up a hot line for illegal aliens “who **believe they may be** U.S. citizens or victims of a crime.” See insert.

The president is now proposing to change the “hardship waiver” for illegal aliens with parents or spouses who are American citizens living in the U.S. Currently, those illegal aliens are required **to leave the U.S. first** if they want to file paperwork for a family hardship. The “hardship” would have to affect the American citizen—not the illegal alien. Obama's proposed change would allow the illegal aliens to stay in the U.S. while waiting for their paperwork to be processed—usually about six months. A foreign national who is **deported** for being illegally in the U.S. for more than 12 months cannot re-enter the U.S. for 10 years—so, just claim a “hardship.” **There will be so much fraud in those “hardship” cases that none of those illegal aliens will be deported—adding to the American taxpayer burden.** If the president gets his way, there will be **IMMEDIATE AMNESTY** in all his programs, which means **IMMEDIATE VOTERS!**

Which brings us to ObamaCare. With or without ObamaCare, **illegal aliens will receive free health care** because hospitals will not refuse treatment and will not inquire about immigration status. American citizens have to show ID and, unlike illegal aliens, Americans have a **valid** address and the hospital can find them and force them to pay. The IRS is the enforcer of ObamaCare, and they are ruthless. If you do not buy health coverage, you will have to pay the **FINE** for not having coverage. If you don't pay that, will the IRS come to your home or shut down your business and seize your assets. They have that power. Will IRS be using “debtors' prisons” for people who don't pay for health care? Although federal imprisonment for unpaid debt has been illegal in the U.S. since 1833, more than a third of U.S. states allow “borrowers” (loans, credit cards, etc.) who can't or won't pay to be jailed. Twenty judges across the nation said the number of borrowers threatened with arrest in their courtrooms has surged since the financial crisis began. Retailers, credit-card issuers, landlords and debt collectors are the most frequent seekers of such orders. Will IRS use debtors' prisons to collect for ObamaCare? Why is the IRS, the **tax collection agency**, in charge of enforcing ObamaCare? The government says that if you don't buy health care, you pay a **FINE—NOT A TAX**. See insert.

The Administration says it will not take away Social Security. True—they will leave it alone until it collapses, and there is nothing to take its place. The proposal for a different retirement fund is being demonized as taking away the safety net for the elderly—**NOT TRUE**. That proposal, will not take Social Security away from those already on it or within a certain time of being on it; but it will create a different plan for future generations that will be in place when Social Security collapses. **“Government money” is not paying for Social Security. It is taxpayer money.** To senior citizens: Do not let the meatball and spaghetti dinner politicians **DECEIVE** you. They have already spent “Social Security.” Your children and grandchildren will have nothing if we don't get a Plan B to replace Social Security for their retirement.

Rhode Island passed Voter ID legislation in 2011, and the R.I. Secretary of State was to issue free State ID cards on January 3. The mayor of New Haven, Connecticut, wants to let illegal aliens vote. Is the DOJ going after New Haven? No, the DOJ is, again, attacking sovereign American states that are trying to protect the vote--by suing them for civil rights violations. The “poor” and “minorities” (which include illegal aliens) have advocates and free legal services for their protected classes that will **NEVER** allow them to be disenfranchised from anything! If it's something they want, they do it easily. If it's something they don't want, they just manufacture another “crisis.”

Which brings us to Rhode Island. There are many hundreds of so-called non-profits in Rhode Island for the “poor” and “minorities.” They are sacred cows and never to be questioned. Why, then, is ProCAP being investigated? It would not be happening unless the powers that be have something to gain. Which agency will be taking over? Who will benefit from the demise of ProCAP? Where will that ProCAP money be going. **Where is our taxpayer money going?** All these agencies get taxpayer money—federal or state or both. What are they doing with the money, and how does each of these agencies help the “poor” and “minorities”? **FOLLOW THE MONEY!**

We do not have a “do-nothing” Congress, and Congress is not being obstructionist. **If a proposal is bad for our country, Congress has a duty to say NO! If every proposal is bad, they have to keep saying NO! There is no compromise on our country!** And, it's not only Republicans saying NO! Some Democrats (obviously not Progressives) are right there with them—sticking up for the country.

The president will not allow America to be energy independent. We have the resources, it will create jobs and strengthen the economy, but it does not fit in with the plan for **world government**. Buying oil from other countries allows **world government** to control America, to make sure America “knows its place”—not unique, not exceptional, not sovereign, not free—but only a small part of **world government, and America will do what all those other kind and gentle countries tell it to do**. The president gets campaign money from both those who want the pipeline and the so-called “environmental” organizations who are against it. He wants to keep it all, but he has until February 12 to make a decision. Those “environmental,” “green,” and “wildlife” organizations do not care about the environment or anything else-- **but they DO care about the political power and the money they get from government grants and from the American people who actually believe their “donations to the cause” are legitimate**.

Energy independence would end the president diverting taxpayer money to finance “green” energy projects for his friends and associates--projects that are not market-ready and are destined to fail. The people running this administration **are not** stupid, and they **are not** making mistakes. These “green” projects are diversions. They were already failing; they were given our taxpayer money; and they failed. **So, where did our money really end up? Where did stimulus money go?** “Shovel-ready” jobs? There were **NONE.
